## **CIP Meeting Minutes**

May 30th, 2023

Attending: Maria Watkins, Ken Henderson, John Sherman, Mark Sherwood, Karl Ingoldsby, Jack Sapia, John Hughes, Sue Sherman (representing budget committee)

The meeting was held at the SAU106 office located at 30 Greenough Rd. in Plaistow, NH. Mr.

Henderson called the meeting to order at 7:00pm.

Minutes from the 4/28/2023 meeting were approved by consensus.

After some discussion it was agreed to that a new column be created for "back burner" or non-priority items that will remain on the list but also not have a dollar cost associated with them. Items for the PAC connector and access road study will be moved to this column.

A discussion ensued on which year we should start to make a list of recommendations for the school board. It was determined that the district has roughly \$1.8M in capital funds that were approved for projects that were slated in 23/24 that had been already completed in 22/23. As a result the committee decided to focus on 23/24 to start for the recommendation list.

The list of new CIP items brought forward by principals and directors was presented as well as items from the EEI projects that Mr. Ingoldsby identified as needing to be added to the CIP. The existing CIP list was first reviewed with Mr. Ingoldsby making suggestions on which items slated to be completed in years beyond could be moved up to 23/24. The committee then reviewed the new requests and the members made suggestions on what could be moved into 23/24 with a priority on safety and security items.

The following items were approved by the committee to be recommended to the school board for capital spending for 2023/2024.
