Discussion:

- Changed in second bulleted competency because this competency exists in seventh grade curriculum
- Replaced with "Students will demonstrate the ability to identify basic food categories, describe what a
 balanced meal looks like, describe easy to make healthier meals, and describe the nutritional benefits
 of various foods."
- SA: Is this a new competency? MP: I will check. It does not exist in seventh grade curriculum.
- LC: Can we add on to the existing competency?
- MP: FACS teacher felt as though the balanced meal and concept of what a meal is, is missing from the curriculum.
- LC: Is there a competency from Health that could be included?
- Suggestion: Add "in order to meet the intended goal."
- SA: Choice-vote or send for a second read
- Sandy made a motion to accept the "Grade 6 Cooking: Foods" for a first read. Approved 9-0-0

TOPIC: IReady Fall 2022 District and School Results

Discussion:

- SA: Overview of Iready platform. Three times a year diagnostic tool, as well as a platform for students to practice skills in math and reading. Instructional component purchased through ESSR funding called "My Pathway". Five achievement categories: Mid/Above Grade Level, Early/n grade level, One year below grade level, two grade levels below, and three or more grade levels below. The diagnostic assess grade level standards so the meaning of yellow will change throughout the year.
- Discussion around slight dip in growth in the spring for grade 8
- SA: Other districts are starting to utilize diagnostic for 9th grade students to identify students that may need support.
- Compared fall benchmark scores 21 to 22. Some slight positive changes year over year.
- KM: Beyond reporting out to Principals and Directors how is this data utilized at the school level.
- SG: Used to create intervention and extension groups with targeted skills
- SA: If we did share the Iready data, what do you recommend we bring to the board?
