# NCPA Bid Proposal Running Track & Tennis Court Renovations Plaistow, NH

#### **Running Track Renovation**

Prices are based on the NCPA (National Cooperative Purchasing Alliance) program. NCPA provides competitively solicited pricing for preferred products and services. Because these products and services have been bid at a national level, individual public entities do not need to duplicate their own bid process.

**Please Note**: It is the opinion of Cape & Island Tennis & Track that the existing surface cannot be resurfaced again, despite looking like it might be reasonable to do so. This type of surface needs to breath to allow vapor to escape. Once surface reaches a certain age and has been previously recoated, embedded silt and organic materials, plus the additional coatings have reduced its porosity. Therefore we recommend surface replacement when the surface becomes no longer acceptable for its intended use.

#### Option 1: Surface Replacement & Asphalt Overlay Method

General: This proposal is for the complete replacement of the existing running track surface from all surfaced areas (track, high jump, horizontal jumps and pole vault) located at Timberlane Regional High School in Plaistow, NH. Included in this option is the removal and disposal of the existing track surface, the installation of a 1.25" asphalt overlay, and the installation of a new upgraded track system.

#### Cape & Island Tennis & Track to Provide:

- Remove & dispose of the existing synthetic surface from track and field events.
- Clean existing asphalt base.
- Make repairs to existing asphalt base where necessary.
- Cut out approximately 400sf of high jump apron and replace subbase materials.
- Patch with 3" of bituminous concrete.
- Install asphalt tack coat prior to overlay.
- Install 1.25" bituminous concrete overlay to running track oval and high jump and runways.
- Install 3" bituminous concrete pavement to pole vault and long jump runways.

- Install 1 in-ground takeoff tray system per runway (2 total). Triple jump lines to be painted.
- Install 1 new in-ground stainless steel pole vault plant box.
- Install Maroon <u>BSS-100</u> polyurethane paved mat structural spray system (an IAAF certified product), manufactured by Beynon Sports Surfaces of Hunt Valley, MD
- Install NFHS certified line markings.
- Project shall be managed by an ASBA Certified Track Builder
- "As Built" layout drawing for striping

Please Note: This tennis court proposal is for installation during the summer/fall of 2018, based on project specifications.

I. Rebuild existing 208' x 120' courts in post tensioned concrete including new net posts, nets, 4 coat Plexipave surface and game striping – includes **25 year warranty** against structural cracking.

**NCPA Co-Op Price:** \$213,879.46 (\$77.12 per square yard)

#### **Additional Work Required:**

- II. Remove and dispose of existing fencing, net posts and footings
- III. Pulverize existing asphalt.
- IV. Layout new court, augment sub base with additional material as needed, compact and laser grade to .83% slope

V. Furnish and install new 1 3/4" black fusion bonded 9 gauge tennis fencing at 10' high with 2 gates
