The Timberlane Regional School Board will hold a Special Meeting of the Legislative Body of the Timberlane School District on October 21, 2021, at 7pm, at the Timberlane Regional High School Gymnasium, 36 Greenough Road, Plaistow, NH.

This Special Meeting is being held pursuant to RSA 197:3-a for the purpose of appropriating additional adequacy funding provided by the State. The legislative body will be presented with a single warrant article requesting an appropriation of this additional adequacy revenue. The legislative body will deliberate and vote in a single session, and cannot act on any other business at this Special Meeting.

To the inhabitants of the School District of the Towns of Atkinson, Danville, Plaistow, and Sandown, New Hampshire, qualified to vote in District affairs:

Special Meeting of Legislative Body of the Timberlane School District Per RSA 197:3-a:

You are hereby notified to meet at the Timberlane Regional High School Gymnasium, 36 Greenough Road, Plaistow, New Hampshire, on Thursday, the 21st day of October 2021, at 7:00 p.m. This Special Meeting is held pursuant to RSA 197:3-a and shall consist of explanation, discussion, debate, and voting on Warrant Article 1 (to appropriate additional adequacy funding from the State). At this Special Meeting, Warrant Article 1 may be amended subject to the following limitations: the legislative body may approve or disapprove the proposed increase of appropriations but shall not approve greater reductions than what is in the warrant, or reduce or rescind an appropriation not specified in the warrant, or act on any other business at the meeting. The Supervisors of the Checklists for the member Towns shall use the most recently updated checklist of registered voters for this Special Meeting.

Article 1 - Additional state adequacy funding, non-lapsing appropriation

Shall the voters of the Timberlane Regional School District vote to appropriate \$991,392.94 for the purpose of buildings and grounds maintenance and improvements. Said sum available due to statutory changes resulting in an increase in state adequacy payments. This special warrant article will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the buildings and grounds maintenance and improvements projects are complete or by July 1, 2024, whichever is sooner. (The School Board recommends this Article) (Majority vote required).
